

TOWN OF MORRIS

BY-LAW NO. 03/08

BEING A BY-LAW OF THE TOWN OF MORRIS AUTHORIZING CERTAIN CHARGES FOR WATER AND SEWER TO BE ADDED TO THE TAX ROLL.

WHEREAS Section 252(2) of the Municipal Act, L.M. 1996 provides in part as follows:
“A charge...may be collected by the Municipality in the same manner as a tax may be collected or enforced under this Act. Section 34 of the Municipal Act states: “A municipality has a lien on all the personal property of a taxpayer for the amount of the taxes in respect of any personal property or business of the taxpayer”.

NOW THEREFORE, the Council of the Town of Morris enacts as follows:

THAT the following water and service accounts being in arrears be now added to the 2007 Tax Roll:
